

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to **www.vashti.online, www.vashtigoracke.com, and www.kingdancefilm.com**, and VG Talent & Services LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to VG Talent & Services LLC include **www.vashti.online, www.vashtigoracke.com, and www.kingdancefilm.com** and VG Talent & Services. The VG Talent & Services website is an E-commerce, professional services, sales site, and blog site. By using the VG Talent & Services website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, VG Talent & Services may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- Email Address
- Phone Number
- User Analytics

If you purchase VG Talent & Services' products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

VG Talent & Services may also collect anonymous demographic information, which is not unique to you, such as your:

Use of your Personal Information

- VG Talent & Services uses a third-party CRM system called Honeybook to serve clients, sign client agreements, and sell professional services. Client information, transactions, and credit card information stored for auto-pay will be used on this CRM system.

Sharing Information with Third Parties

VG Talent & Services does not sell, rent or lease its customer lists to third parties.

VG Talent & Services may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, address, telephone number) is transferred to the third party. VG Talent & Services may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to VG Talent & Services, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
